•	An adequate road bed of suitable material to support the projected traffic and any requirements
	for culverts shall be determined by the Town Board (Chairman) in considering an application for
	driveway approval.

- If culverts are required the minimum size permitted by the Townships is 18" by 30' plus apron end-walls. Town Board approval required for other size culverts.
- Any construction in the right-of-way, including retaining walls, culvert end walls, etc. must be approved by the Town Board
- At the dead end of the driveway, a turnaround of at least 25 foot radius or some other method to allow vehicles to turn around shall be provided.

All driveways shall be constructed in accordance with the above requirements and other specifications as may be set forth by the Town Board (Chairman). The maintenance of the driveway shall be the responsibility of the applicant and/or owner.

Note: It is the responsibility of the owner to check with the DNR and the County to see if any other permits are needed.

By the execution of this application, applicant hereby authorizes the Town of Theresa or its agents to enter upon the property for the purpose of inspection.
